Introduction

As a responsible and ethical business, Kagome Australia acknowledges the significant risk of modern slavery in global supply chains and we are committed to identifying, preventing and mitigating this risk in our operations and supply chains.

This statement serves as our first annual modern slavery statement and outlines our approach and efforts to address modern slavery in accordance with the Australian Modern Slavery Act 2018. We recognise the importance of transparency, accountability and collaboration with our stakeholders in this journey and we are committed to continuously improving our practices to combat modern slavery in all its forms.

Structure, Operations and Supply Chains

Kagome Australia is a subsidiary of Kagome Co. Ltd, a Japanese multinational food manufacturer. Kagome Australia operates in the food industry, primarily producing fruit and vegetable-based products such as paste, diced tomatoes, sauces and powders for B2B and foodservice channels.

Operations are primarily located in regional Victoria and New South Wales, where the company operates a processing facility and has various farming locations. The company sources numerous fruit and vegetable raw materials from local growers in Victoria and New South Wales. Additionally the company sources its packaging materials and other ingredients inputs from suppliers in Australia, Asia, Europe and South America.

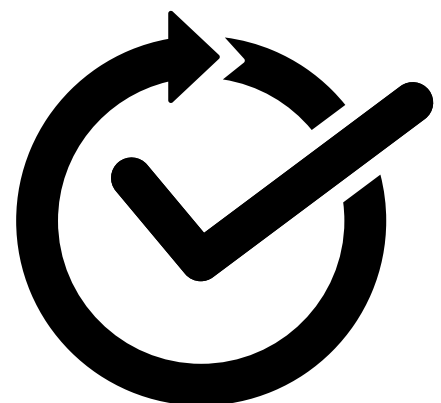


Modern Slavery Practices

We have developed a comprehensive Human Rights policy that aligns with the Australian Modern Slavery Act 2018 and the UN Global Compact as a guiding framework. Additionally we have been a member of Sedex (empowering responsible supply chains) since 2017 and passed our first SMETA audit in 2023.

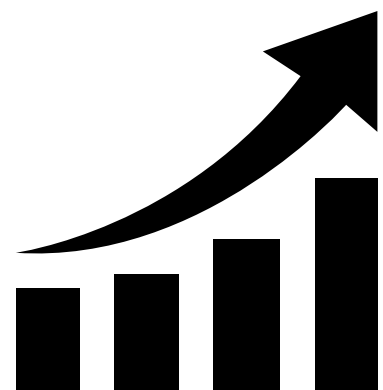

- Providing training to our employees on modern slavery awareness and prevention
- Working towards certification under ISO 45001




Consultation
